

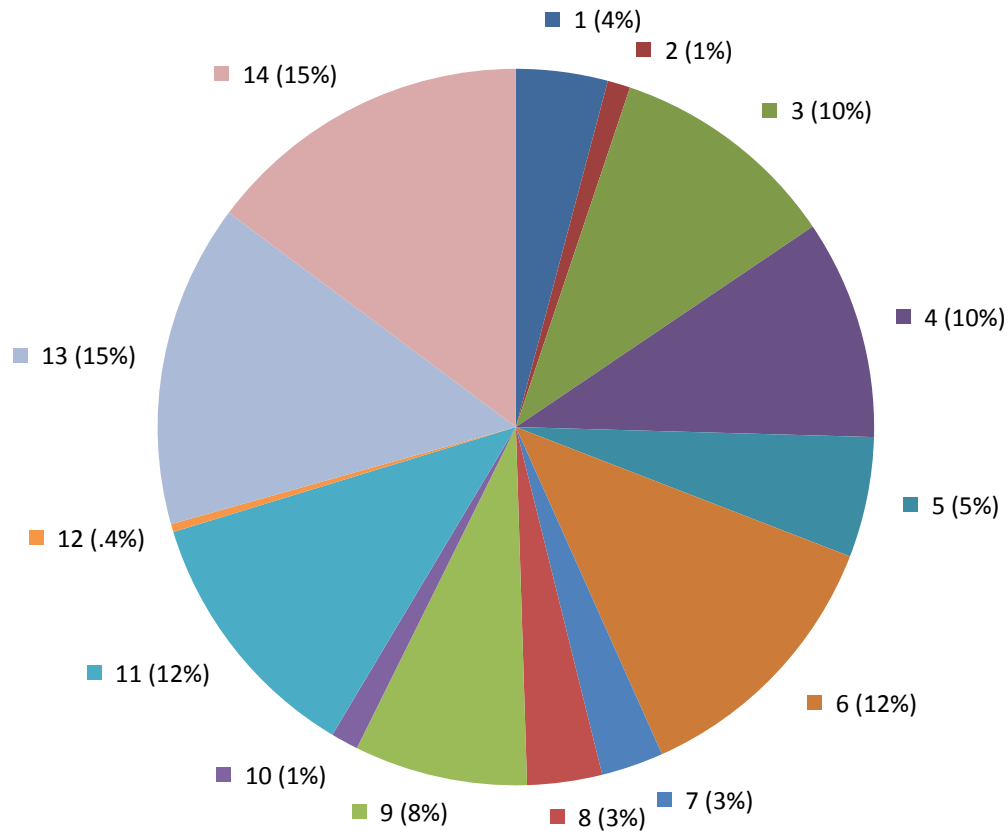

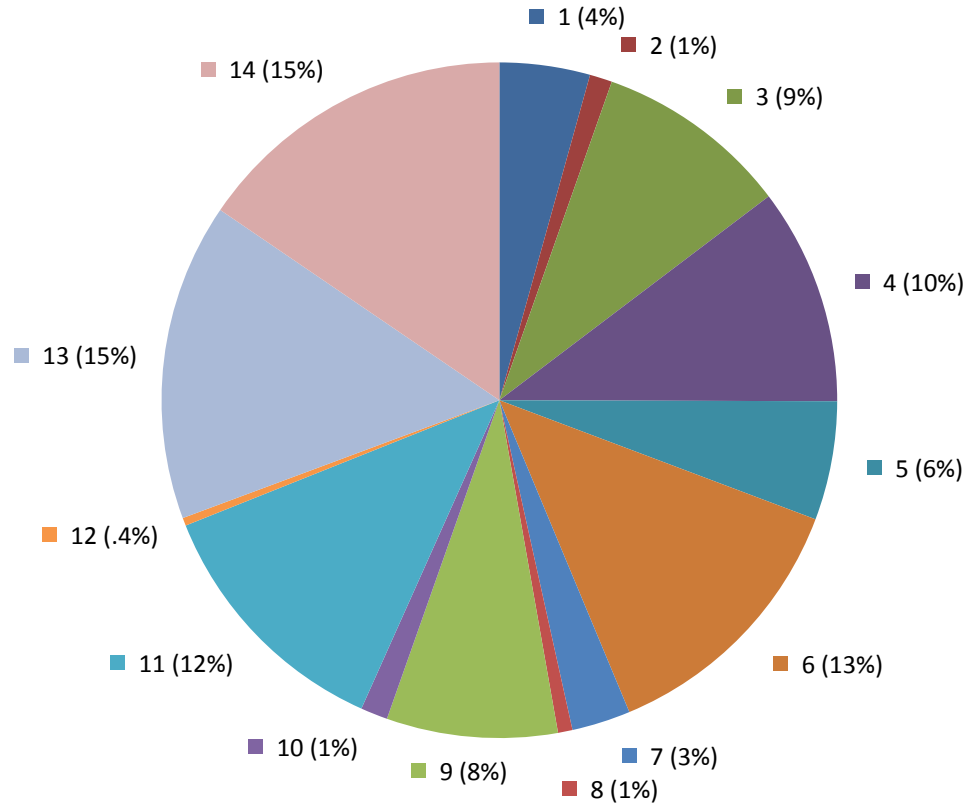

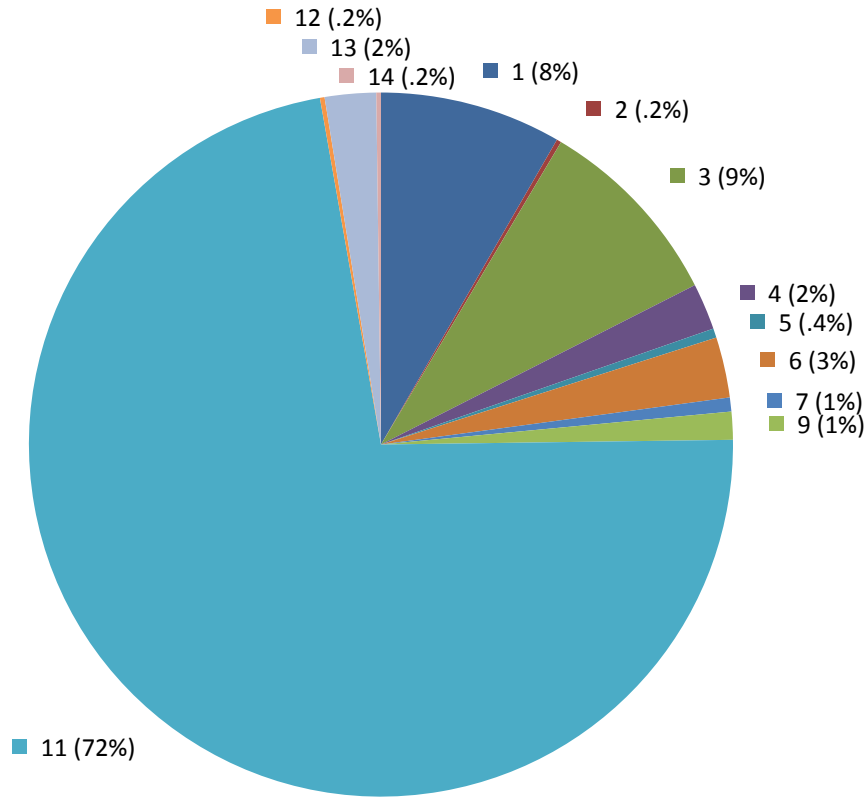

Magistrate Judges Total Cases by Nature of Suit**



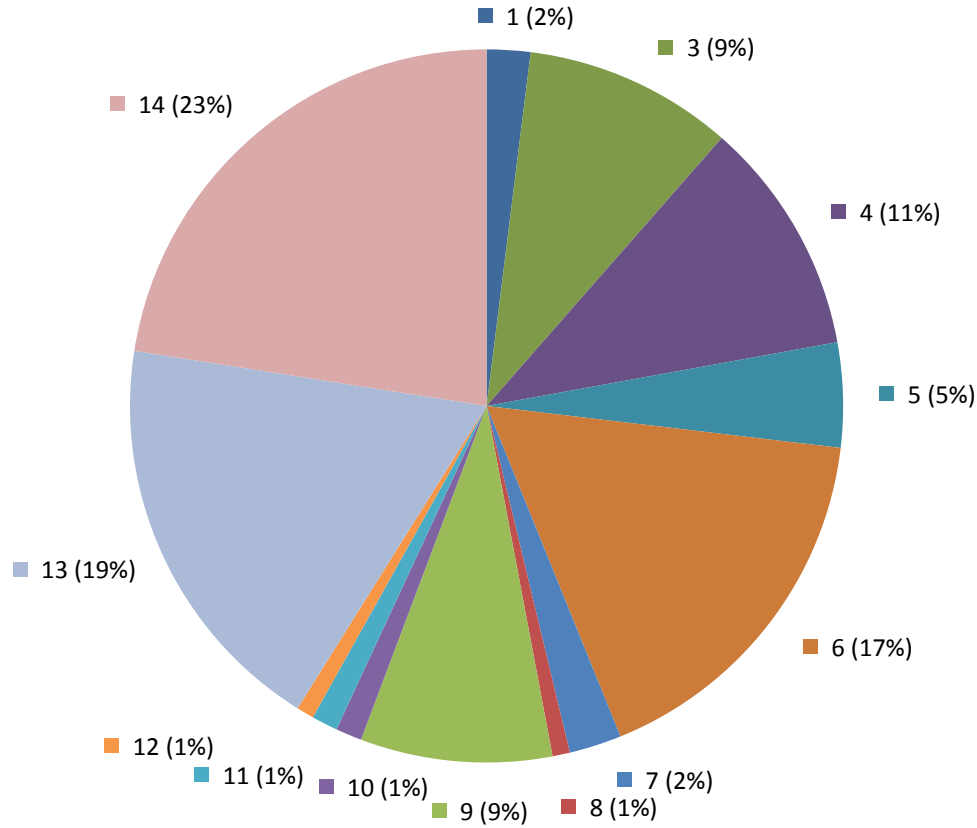
