

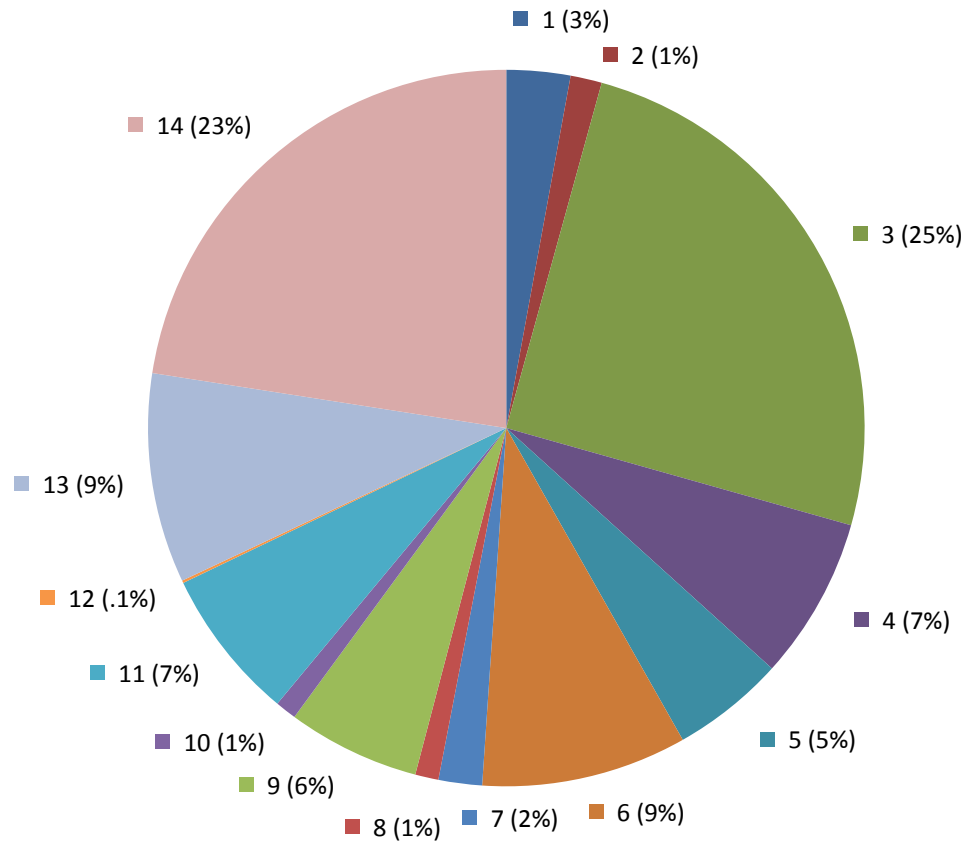

District Total Cases by Nature of Suit**



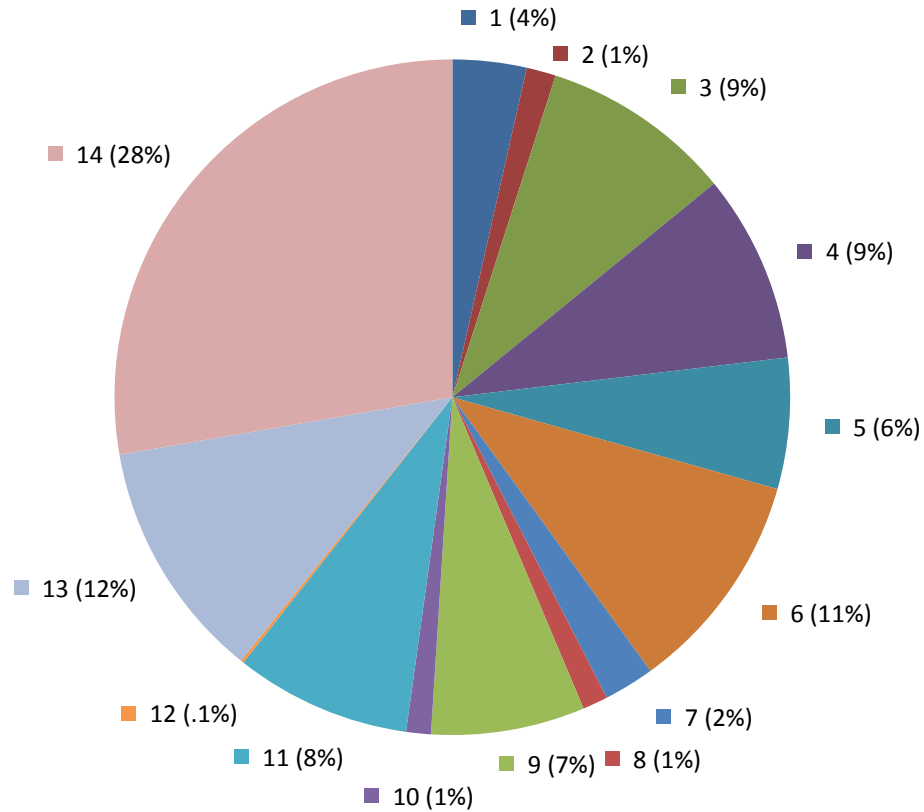

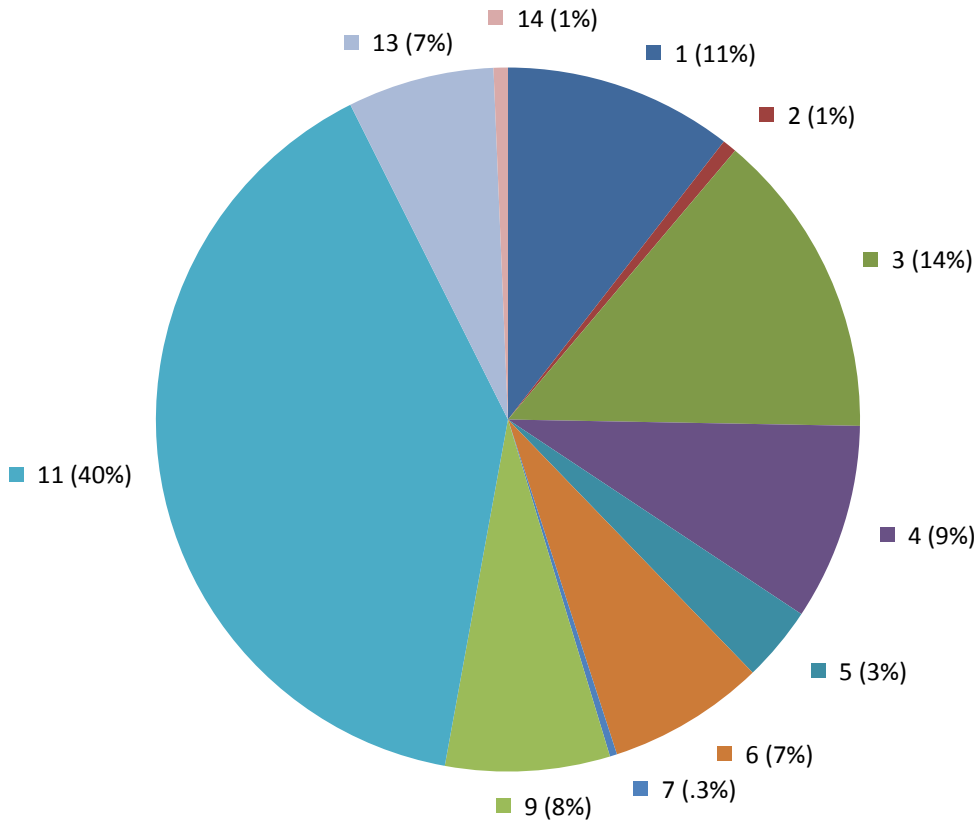
